To *George Mumma and Nicholas Bower*  
*of the County of Lancaster Yeomen* Greeting.

Whereas *John Baughtman* late of *Township in*  
*the said County Yeoman*

lately died intestate (as is affirmed) *he* having, whilst *he* lived, and at the time  
of *his* Death, divers Goods, Chattles and Credits within the said Province and Counties  
by Means whereof the full Disposition and Power of granting the Administration of all and sin-  
gular the Goods, Chattles and Credits of the said Decedent, and also auditing the Accounts Cal-  
culation and Reckoning of the said Administration, and a final Dismission from the same to me  
is manifestly known to belong. I desiring, that the Goods Chattles and Credits of the said Dece-  
dent may be well and truly administred, converted and disposed of to pious Uses, Do hereby  
grant unto you the said *George Mumma and Nicholas Bower*

(in whose Fidelity in  
this Behalf I very much confide) full Power by the Tenor of these Presents, to administer the  
Goods, Chattles and Credits of the said Decedent within the said Province and Counties: And  
also to Ask, collect, sue for levy, Recover and receive the Credits whatsoever of the said Dece-  
dent, which at the time of *his* Death were owing, or to him did in any wise belong,  
and to pay the Debts, in which the said Decedent stood obliged, so far forth, as the said Goods  
Chattles and Credits will extend according to the Rate and Order of Law, especially of well  
and truly administring the Goods, Chattles and Credits of the said Decedent and making a true  
and perfect Inventory of all and singular the Goods, Chattles and Credits of the said Decedent,  
and exhibiting the same into the Registers Office at Lancaster at or before the

*eighth* Day of *November* next ensuing and rendring a true and  
just Account, Calculation or Reckoning of the said Administration on or before the  
*eighth* Day of *October* which will be in the Year of our Lord one Thou-  
sand seven Hundred and *fifty eight* And I do by these Presents ordain, con-  
stitute and depute you the said *George Mumma and Nicholas Bower*

Administrators of all and singular the Goods, Chattles and Credits of the said Decedent  
wit<sup>h</sup> in the Limits aforesaid, saving harmless and for ever indemnifying me and all other  
Officers against all other Persons by Reason of your Administration aforesaid, and saving  
To every on their Reights. In Testimony whereof I have hereunto set my Hand and af-  
fixed my Seal of Office at Lancaster the *eighth* Day of *October*  
in the Year of our Lord one Thousand seven Hundred and *fifty seven*
